## Summary of Your Benefit Option and Type of Medicare Part D Coverage

The Medicare Modernization Act ("MMA") requires you Board of Education Washtenaw County to notify all Medicare eligible individuals with prescription drug coverage under the Plan whether their prescription drug coverage is creditable coverage.

Coverage is considered "creditable" if its actuarial value equals or exceeds the actuarial value of standard prescription drug coverage under the Medicare prescription drug benefit. If coverage is not creditable, there are limitations on the periods during the year in which you may enroll in a Medicare drug plan and you may be subject to a late enrollment penalty. Your coverage in this Plan is creditable.
